### 2. Branch Advocacy Priorities Survey Results from February

In the February newsletter, I invited you to complete a short survey to let us know the importance you attach to the questions that we will be asking MPs at a future meeting. In addition, we wanted to know what claim situations concern you so that we can present them to the MPs during our meetings with them.

Two topics emerged clearly from the survey in terms of the issues:

- Home care: Several members believe that keeping seniors at home should be the Association's priority, particularly an increase in the assistance available and the tax credits offered to them and to caregivers.
- 2. Dental and drug insurance: The members consider that the coverage does not keep step with indexation and above all, many are asking that dental insurance be at the same coverage as for federal employees. Many are calling for the abolition of the 80% coverage ceiling, or even full reimbursement of 100%.

With respect to the Public Service Health Care Plan (PSHCP), regular meetings have taken place since the bargaining process began in earnest. Although progress was slowed due to the 2021 federal election, in February 2022 the three partners (employer, bargaining agents and pensioner representative) met.

During this meeting, the employer announced that it had received its mandate from the President of the Treasury Board, which means that negotiations on the renewal of the plan continue to move forward and that all parties are committed to reaching an agreement quickly.

In addition to these two issues, it should be noted that the pension indexation rate has caught the attention of some members who consider that the rates do not represent the true rate of inflation.

Other topics covered include severance pay, access to care, health care funding, long-term care, and help with Phoenix issues.

Thank you for completing the survey. Supporting advocacy for your interests is our number one priority.

#### 3. Survey on Severance Pay

Federal retirees who worked in the public service before 2011 are entitled to severance pay calculated based on years of service. However, several of our members have told us that they have experienced great difficulty in obtaining this within a reasonable period of time after retirement. Others are still waiting to obtain information on the time frame for care and treatment.

We invite <u>members affected</u> by this situation to participate in this survey in order to know the extent of the problem so that we can inform the National Office and be able to consider local support measures.
