ARE YOU PREPARED? Submitted by Frank Bayne

Over the past years I have assisted several BR 39 survivors with the steps involved after the death of a pensioner. It is a stressful time and can be confusing to your survivor as they deal with their loss and all that follows. It takes time and patience to make it through the process.

PENSIONERS: You have a responsibility to keep your files up to date.

Dig out the <u>YOU AND YOUR SURVIVORS</u> workbook. Have you made and updated the entries? Part 2, Section 1 is a very important part of that workbook.

PENSIONERS: The best thing you can do for your survivor is to ensure that your pension number, SIN number, Military service number, Veterans 'K' card number, insurance policy numbers, bank accounts and investment account numbers are on an easy-to-access list, in an easy-to-access place!

RCMP Pension Office

Have the following information ready:

• Pension number (from the Direct Deposit Payment Statement issued each January)

- Full name
- SIN number

ASK them to send you the Survivor's Package. They will tell you to mail or fax (the better method) them the following, unless you have already sent the information in to be placed on your file:

Marriage certificate

Divorce decree, if applicable

- Spouse's birth certificate
- Copy of will
- Death certificate

As soon as they receive the information they will mail you the package. This will contain

• The amount of Survivor's pension and the amount of the Supplementary Death Benefit (this SDB is NOT Taxable)

• A note to indicate that the survivor is entitled to the pensioner pension for the full month in which they died. All other payments must be returned.

• Instructions on completing an Application for the Public Service Health Care Plan and

the number if you want to maintain the Pensioner's Dental Services Plan (PDSP)

Instructions for direct deposits of the pension (sending a VOID cheque)

CPP/OAS The funeral home normally does this, and they will have several copies of the death certificate for distribution, as required. If they don't, call 1-800-277-9914 They will require:

- Death certificate
- Marriage certificate
- Spouse's birth certificate
- Copy of will
- Funeral bill

YOU will receive the <u>CPP Surviving Spouse's pension</u> and the <u>CPP death benefit</u> (maximum of \$2500.00) payable to the estate of the Deceased. **This IS taxable. REVENUE CANADA** They will want the deceased's SIN number, a death certificate and a copy of the will. Kitchener Office: 1-800-959-8281

OTHER PENSIONS They will want the pension plan number, death certificate and a copy of the will

LIFE INSURANCE They will want a copy of the death certificate and a copy of the will

BANK Don't close the accounts until everything is settled. To close the account, they will want a copy of the death certificate and the will

VAC Veterans' Affairs Canada 1-866-522-2122

Call them and give the 'K' card number and full name of Veteran.

Surviving spouse should get 100% of the pension for the first year following the death of the veteran, and then 50% after, plus VIP services will continue for the surviving spouse.

FSNA National Association of Federal Retirees

When the pensioner dies, their members and the spouse's memberships ceases since the 'Dues deduction' ceases. **O**nce you receive your first Survivor's pension cheque with a pension number, send an application to remain an FSNA member to Ottawa.
