# **President's Notes:**

# Sidney and District Branch 2016 Financial Results and Proposed Budget for 2017

The Branch financial records for 2016 have been audited. We are in good financial order. The balance sheet and the revenue & expense statement for 2016, as well as the proposed Branch budget for 2017 are at the end of this newsletter. These financial statements will be presented for agreement at the Annual Meeting on 18 Feb.

# Re-Iteration of Establishment of The Branch Members Support Fund:

We need to have a named fund in our Branch accounts to hold money raised by Branch fund-raising activities (50/50 draw, sale of Estate Documents, silent auction proceeds, etc.) for Branch purposes as well as money received as donations to the Branch. The fund will **not** include any money accruing to the Branch from the Branch share of members' Association membership fees. The fund must be established by a resolution passed by a majority vote at a Branch general meeting. All of our quarterly meetings are general meetings. Establishment of such a fund (sometimes called a reserve) for specific purposes is authorized by NAFR Regulation 4.3 "Branch Reserves and Branch Surplus Funds" and that expenditure from this fund for donations to specified beneficiaries is authorized by NAFR Regulation 5.3. The Regulations cited are those included in the edition of the Regulations passed by the national NAFR Annual Meeting of Members in June 2016 and confirmed by the National Board of Directors in December 2016, as carried on the Association internet web site on 30 January 2017.

# The resolution will be:

Moved by David Stinson, seconded by Catherine Schuetze, that the Sidney and District Branch (BC 14), NAFR, continue to establish and maintain a named fund in its financial accounts to hold money raised by Branch fundraising activities or received as donations to the Branch known as the Branch Members' Support Fund. The Fund is allocated to Branch local purposes, specifically:

- a. Donations to one, some or all of the following institutions for their seniors support activities: the Saanich Peninsula Hospital Foundation, the Mount Newton Centre Society, The Lodge at Broadmead and Victoria Hospice;
- b. Significant Branch events in support of members as a group; and
- c. Contributions to worthy causes (not individual persons) not named above.

The Fund will be managed by the Branch Executive and will be shown in the annual report to the Association National Office as a Branch asset. Expenditures from the Reserve will only be made when approved by Branch members at a quarterly general meeting. This resolution replaces the similar resolution passed at the Branch quarterly general meeting held 13 September 2014.

# Annual Victoria 55+ Lifestyle Show – March 21, 2017 – G.R. Pearkes Recreation Centre (behind the Tillicum Mall) – National Association of Federal Retirees Recruiting Booth

Sidney and District Branch will join with the Victoria - Fred Whitehouse Branch at a NAFR recruiting table at the Lifestyle Show. Planning to visit? Bring a Public Service, Armed Forces or RCMP colleague who hasn't yet joined the Association to our booth for information. We can answer questions about the value of being a member. They don't have to be retired to join.

# 2017 Premium Increase - Public Service Health Care Plan (PSHCP)

At 31 January, the Treasury Board had not yet announced the amount of the increase in PSHCP premiums for retirees which is due to take effect 01 April 2017. The increase is part of the shift of the former employer/retiree premium payment ratio from 75/25 to 50/50. The changes began in April 2015 and continued in April 2016. The third round of changes, due to begin in April 2017, will move the ratio to 56.25/43.75. The change will probably be announced in February in an issue of the PSHCP Bulletin.

Association Application for Judicial Review of the Government of Canada Order to Change the PSHCP Premiums for Federal Retirees. The application was to be heard in Federal Court in November 2016. The hearing was postponed at the request of the Association's lawyers. The hearing is now scheduled to open at 09:30, 10 April, 2017, in the Federal Court at Ottawa. The case is Loretta Bemister et al v. Attorney General for Canada, Federal Court docket T-311-15.

# **Indexation Increase for 2017**

The increase for 2017 is 1.3%, payable beginning 01 January for federal retirement pensions and the Canada Pension Plan. The increase in Old Age Security payments will follow later.

# **British Pensioners**

If you lived and worked in the United Kingdom, contributed to the British national pension scheme long enough to earn a UK pension and now live in Canada with that pension "frozen" at the level which applied when you left the UK, ie., - no indexation allowed, you may want to consider the Canadian Alliance of British Pensioners (CAPB). The campaign to gain indexation continues, with CAPB and its affiliate organizations in other "frozen" countries leading the charge. #### **Elections BC – Notification of Death**

When a member dies, the spouse or the executor should advise Elections BC of the death. Elections BC will remove the member's name from the Voters' List and will also tell the jury selection secretariat. This should avoid the emotional upset involved when survivors receive election notices and jury selection invitations sent to their late spouse. Call 1-800-661-8683. Elections BC will advise Elections Canada of the member's death.

Branch total membership at 30 January 2017 was 1417 - 964 pensioners and 453 spousal members. 87% of our members now pay their membership fee through the Dues Deducted at Source (DDS) system. 67% of Branch members receive the Newsletter by e-mail – this percentage is growing - thank you, members!

# Membership Fees and Membership Renewals - 2017

The annual membership fees for 2017 are: for single members \$47.76 (those who are single or who are survivors or who are married but have not yet signed up their spouses); for members and spouse (dual or double membership) \$62.04. Unless you pay your membership fee through the Direct Deduction at Source (DDS) system as a member or as a survivor, it is your responsibility to renew your membership within 90 days after expiry of the previous membership period - eg., if your membership expired 31 December 2016, you need to renew by 31 March 2017 to ensure no connections are lost. If you have any difficulty renewing your membership, please contact Patricia Stevens. Please note that if you are not paying the fee through the DDS system and prefer not to use cheques, you can pay your membership fee using a credit card - please contact the National Office staff at 1-855-304-4700 and ask for membership renewal. Payment of membership fees by debit card is not available.

To members who pay their membership fee directly to the Branch, except for those who continue to serve in the Canadian Armed Forces, the RCMP or the Public Service or who are not pensioners or survivors under the *Judges Act Canada*, we ask that you consider changing to the DDS system. Paying by DDS is at no cost to you. If you wish to join the DDS system, we will have forms available at the November meeting. To complete the form, you will require your PENSION NUMBER as shown on the cheque stub from your pension source or, if your pension is deposited directly into your bank or credit union account, as shown on the form you should receive periodically to advise you of changes in amounts payable or changes in deductions. To assist the Membership staff at our 18 February meeting, please do not pay by cash. Members paying the fee at this meeting are asked to come early and drop off the cheque at the membership desk.

# Are You Moving or Planning to Move or to Change Your E-mail Address?

If you change your postal address, telephone number(s), e-mail address(es) or you elect to pay your membership fee through the DDS system, please tell Patricia Stevens. Patricia will ensure that the National Office records at Ottawa, and our Branch records, are updated appropriately.

# Association (NAFR) Membership and Eligibility for Johnson's Inc. MEDOC Coverage

NAFR members with PSHCP coverage are eligible to apply for the MEDOC out-of-province/out-of-country medical insurance (and the travel interruption coverage) offered by Johnson's Inc at a preferred rate. This is a long-running partnership between the Association and Johnson's Inc. It was possible in the past to cease NAFR membership and continue with MEDOC coverage at the Association rate - this is no longer possible. Johnson's Inc. can now easily check with the National Office to determine if a MEDOC subscriber is a current NAFR member - if there is no current membership, there will be no Association-rate MEDOC coverage.

Please note that there will be no, repeat no, new stickers saying 12/2017 to attach to your membership card to extend the validity date - the Association stopped that practise in late 2016. All preferred partners, any of which may ask to see your card if you are asking to access their service at the Association rates, have been told that there will be no more annual stickers and to accept the membership card as being valid. # Minutes of the Previous Quarterly General Meeting <u>Sidney and District Branch, National Association of Federal Retirees,</u> Quarterly General Meeting, 19 November 2016, 10:00 AM, St. Elizabeth's Church, Third Street, Sidney

President David Stinson convened the meeting at 10:00 A.M. with 85 members present. David welcomed eight new members. He also introduced Emily Pridham, Manager, Regional Services, Alzheimer's Society of Canada, who would be our speaker following the meeting.

# **Presentation of Branch Donations**

To Steve Butler, Chairman of the Board, and Carol Burkowski, leader of the Finance Committee at the **MT. NEWTON CENTRE SOCIETY**, President David presented \$1,000 on behalf of the Branch membership. David explained to members that the Society is in its 38<sup>th</sup> year of operation, is a not-for-profit society and is a charity, dedicated to helping local people with medical equipment loans, transportation and other medical support services not otherwise available in this part of the Peninsula – Central Saanich, North Saanich and Sidney. We can take great pride in supporting its efforts.

Paul Morgan, Chair of the Board of **THE LODGE AT BROADMEAD** accepted a donation of \$1,000 from President David on behalf of the Branch membership. Now in its 21st year of operation, the Lodge is dedicated to helping military veterans of the Second World War and the Korean War, all now in their 90s, live in dignity and safety in utterly caring surroundings.

The Sidney NAFR Branch has been supporting both of the recipient organizations since 2004. David explained that the donation money came entirely from members fundraising activities over the years, none from the Branch share of the Association membership dues. The Branch also regularly supports the **Saanich Peninsula Hospital Foundation** through our In Memoriam donation of \$50 in memory of each Branch member who passes away. He thanked all of the recipients for coming to the meeting. He informed the members present that we may not be able to make all of these donations every year, but would do our best to continue this tradition.

# **General Meeting Points**

President David inquired if anyone had not received the Branch newsletter, November 2016 edition. There was only one hand raised. He stated that copies of the newsletter were available on the membership table as well as the latest edition of the Branch "fridge card" of useful telephone numbers and a small brochure explaining the Association briefly. He suggested if any member knew someone recently retired from one of our "parent"

organizations and who was not yet a NAFR member that he/she should pass him/her a copy of the leaflet and the newsletter for information.

Minutes of the Previous Quarterly General Meeting: Donna Godwin, Secretary.

**Financial Report:** Cathy Schuetze, Treasurer, reported balances of \$11,742.47 in the Operations Account and \$7,217.89 in the Branch Members Support Account. There were no questions. (M) Martha McCracken, (S) John MacGowan "That the Treasurer's Report be accepted as presented." CARRIED

<u>Membership:</u> Patricia Stevens, membership director, reported 963 pensioners and 457 spousal members for a total Branch membership of 1,420. 33% of Branch members receive the newsletter in hard copy through postal mail, all others receive it via e-mail. Pat thanked all those who have changed delivery to e-mail recently as it saves postage costs. She mentioned that if a member no longer wants to receive the newsletter that she can put a no-mail request on the membership list on which the distribution is based and delivery will stop.

<u>Welfare and Estate Assistance</u>: John & Linda MacGowan. John reported that 33 members had been assisted since mid-September. He requested that he be notified if a member passes away - not all deaths are included in the Times-Colonist obituaries - so the bereavement assistance team can get in touch with the deceased member's next-of-kin.

<u>Health Benefits</u>: Martha McCracken, Branch Health and Benefits Officer. Martha reported no inquiries in the past two months.

# Next Branch Quarterly Meeting, 18 February, 2017, Usual Place, Usual Time:

The meeting will be the Annual Meeting of Members and will include election of the 2017 Branch Executive. In order to maintain our Branch, we need a slate of Executive to publish in the Newsletter early February. We need candidates for President and Vice-President. Please let President David know if you can join. Two Association Branches have closed in the past three years because of failure to elect an Executive - we should not join that group! The speaker at the February meeting will be Jim Cotter on the subject of "reverse mortgages", sometimes called "CHIP mortgages".

<u>22 April 2017 Branch Quarterly General Meeting</u>. The meeting itself will be very short. The main part of the time will be devoted to the presentations and responses to questions by the three candidates in this riding in the BC provincial election called for 09 May. We will follow our traditional format - there will be no debate among the candidates, there will be no questions from the floor and the media are not invited.

# **General Meeting Points - Continued**

The recent member survey regarding Branch meetings was a success. David thanked everyone who had been able to reply. The responses were summarized in the November 2016 newsletter.

David stated he was delighted at the turnout at this meeting - 85 interested members is a good sign - may the number keep growing. He noted that our Branch had now been operating for 27 years.

David informed members that Bob Peacock, a long time Branch member and contributor, had recently passed away. Bob was the moderator for several of the earlier candidates' presentations and he was a leader in a Branch project to collect books on history topics and distribute them to local schools. He will be much missed.

A membership note - there will be **no** new stickers issued to update the expiry dates on Association membership cards, as was mentioned in the newsletter. The National Office staff determined that there is no longer a requirement for these updates. Please tell Pat Stevens if you do not have the current plastic card.

A MEDOC note. Until recently, it was possible for federal retirees with PSHCP coverage who had become Association members to join the MEDOC plan (out of Canada medical insurance & travel insurance) offered by Johnson Inc. at the discounted Association premium rate, get established paying the premium from their pension through the dues-deducted-at-source (DDS) system, cease membership in the Association and continue the MEDOC coverage at the NAFR rate - there was no "cross-check". That "loophole" is now closed, given the capability of the new NAFR membership database system. Johnson Inc. can and will check its list of those with MEDOC coverage at the NAFR rate against the NAFR membership list, through the National Office staff. Any person on that Johnson Inc. list who has not maintained his/her Association membership will likely lose that MEDOC coverage at that rate and might lose it altogether. The Association annual membership fee probably costs less than the charge for an hour of basic care in an American hospital! Not paying that fee to save a few dollars monthly, if you will be travelling out of Canada more than 40 days on one trip, is truly silly and could be frighteningly expensive if coverage was lost and the member incurred major medical expenses outside Canada.

Association National Web-Site. www.federalretirees.ca. It is always well worth exploring.

<u>Presentation: Emily Pridham, Manager, Regional Services, Alzheimer's Society</u> was introduced by Denny Gelinas and thanked by David Stinson. She spoke on understanding the disease and the load caregivers have. It was an excellent presentation on a very relevant topic.

**In-House Draw:** Winner was Gordon Hryhoryshen - \$88.50.

<u>Final Comment</u>. Before closing, David noted that our Branch has over 1,400 members. He recognized (from the survey responses) that many members cannot attend our meetings because they can no longer drive, have vision or hearing limitations, or, for other reasons, including where they live - out of town, on the Gulf Islands, etc. - simply cannot attend these meetings. That being said, it should be possible to attain at least 10% of the Branch membership at these quarterly meetings. He asked members to ask other members to attend the gatherings - they are worthwhile.
