- 1. The meeting took place in Oshawa at the 420 Wing RCAFA Club, 1000 Stevenson Rd. N with 5 branch executives, 7 members and 1 guest present.
- 2. Welcome/Call to Order: Pierre Brunet, President of Branch ON44 introduced himself and welcomed all attendees. Thanks again to Lynn from Johnson Insurance for her excellent presentation regarding the travel coverage Medoc
- 3. He then proceeded to introduce the Executive team noting that Vice-President Lesley Humber sent her regrets. Executives attending the meeting were Marcel Lamothe, Treasurer; Sharron Curley, Secretary, Lois Gehan and John Collins, Directors.
- 4. Approval of the Agenda: The agenda was approved with no changes. Motion by Marcel Lamothe, Seconded by John Collins. Carried

Upcoming she plans to add branch specific information for the upcoming Federal Election and will also be busy with the Oct.16 General Meeting in Peterborough.

- 9. Old Business: Pierre mentioned that it is official that bill C-27 died on the books. This is the bill that proposed changes to pensions ..none favourable to our members. This is a relief and very good news.
- 10. New Business: Peter Doherty, an attendee spoke about clawback of CPP from those aged 60 to 65 that would affect veterans and RCMP. He asked for our support providing Pierre a campaign document with the details.. Pierre will forward to Nancy Gleason, head of advocacy for Ontario Branches.
- 11. Adjournment: The meeting was then adjourned. Motion by John Collins.
